

Kia ora Steph

I have scanned over the application documents in the folder and can provide the following high-level feedback:

- There are various references to the 'masterplan' and I assume these references are to the proposed plans in Appendix 3? The appendix 3 plans are headed 'concept design', but is this design sufficiently progressed to provide certainty of outcome? I know in our discussions the feedback was that the design was generally set but sometimes references to masterplan may be more relevant to a structure planning or plan change process rather than specific resource consenting so I just wanted to confirm.
- Existing easements these are referred to in the application as 'hereon' and are drawn on two 'existing site plans' in Appendix 3, but they are not clearly identified from what I could see, e.g. 'A', 'B' and 'C' etc, nor are they shown on any plans in relation to the proposed new buildings/structures. There should be a plan/s clearly showing the existing easements (labelled) in relation to the proposed development.
- Further to the above, there are a range of references to services being redesigned to suit the development and new easements being provided. You will need to clarify whether any existing easements and/or CN and/or covenants need to be cancelled or amended in order to implement the project (as this cannot be considered by a panel). If required, you will need to discuss how any additional approval to remove/cancel or vary easements, CNs or covenants will affect project timing and/or delivery. E.g. if an easement is in favour of a third party do you have agreement in principle for any removal/amendment.
- Project description is to subdivide land and construct and operate a village development. It seems accurate to say a mixed-use development?
- The project is stated to include stream reclamation (page 12), however when you get to the rules assessment it appears this is only in relation to placing a culvert in a stream. If so, it would be good to clarify this in the description as I was looking for further information on stream reclamation.
- I didn't carefully analyse all of the plans, but please check legends and labelling I juts noticed buildings labelled CL-CC on the plans and I don't think this is in the legend.
- The application refers to consent being sought to undertake commercial activities in existing buildings please identify/label these on the plans.
- 'Community Centre' buildings are on the plans but are not included in the project description. Please include in the project description if they form part of the project and describe what these are.
- Riparian enhancement works is this location/s clearly shown on a plan in relation to the development? Mentioned in project description but little other detail. I suspect there may be more in the ecological assessment yet to come?
- Housing typologies heading the detail on options probably needs to be included at the start of the project
 description section so it is clear you are seeking two design options. I suggest you consider how you would
 want/need the Order in Council to read if the Minister decides to refer the project.

- Wastewater wording on page 15 'Relevant staff at Council have confirmed that the upgrade works can be programmed to align with the delivery of the development' is there anything from KCDC to confirm the timing and that this will not be an impediment?
- Water supply 'we understand from our discussions with Council that the works will be undertaken to align with the delivery programme for the development' is there anything from KCDC to confirm timing and that this will not be an impediment?
- Utilities highlighted upgrades required for power supply, provide comment on whether these are being fully funded by the applicant?
- Application details the housing delivery dates align with the milestones outlined in the Housing Outcomes
 Agreement between Kainga Ora and Otaki Revisited Limited signed as part of the IAF agreement. How
 relevant is the Housing Outcomes Agreement and the IAF agreement and is it worth providing with the
 application? Perhaps it has the answers to the 2 questions about re wastewater and water supply
 upgrades?

Generally I would say that the application material is comprehensive and covers the key areas that it needs to (noting you are still to finalise the ecological assessment).

I should note that the application document appears to contain a lot (if not all) of the material that we would expect to see in the application form submitted through the online portal. I would encourage you not to submit a 50 page referral document if a large portion of that text is repetition of the application form. The application form is the official 'go to' document for us and should be able to stand on its own. Reference in the application form to additional supporting reports/supplementary information is fine, but it should be supporting or supplementary to, rather than a repeat of the details in the application form. I'm happy to discuss this further when I am back in the week of the 12th.

Hopefully the above is of some value for now.
