# FTCA #261:- Corrections to applications for referred projects under the COVID-19 Recovery (Fast-track Consenting) Act - Stage 2 decisions

#### **Purpose**

- The purpose of this aide memoire is to correct information related to your decisions to refer the following projects under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (FTCA):
- 2. Rotokauri Greenway and Minor Arterial (BRF-3150) Notice of Decision sent on 30 May 2023
- 3. Peachgrove Mixed-use Precinct (BRF- 3088) Notice of Decision sent on 7 June 2023
- 4. Waiuku Wind Farm (BRF-3153) Notice of Decision sent on 7 June 2023.

#### Background

- 5. You agreed to recommendations in the Stage 2 briefings provided for the Rotokauri Greenway and Minor Arterial, and Peachgrove Mixed-use Precinct projects to include Ngaa Puna o Wairere as an additional party from whom a panel must seek comment. This party was included in the notices of decision issued for the referral of the two projects.
- 6. Paragraph 26 and Table A of the Stage 2 briefing for Waiuku Wind Farm (BRF-3153) states: s 9(2)(f)(ii), s 9(2)(g)(i)
- 7. All comments received on the referral application for this project, including those from the above Ministers, were appended to BRF-3153.

# **Corrections required**

Rotokauri Greenway and Minor Arterial & Peachgrove Mixed-use precinct

8. The intention of our advice in BRF-3150 and BRF-3088 was to include representatives of the Waikato-Tainui hapū Ngaati Wairere (who were identified by the local authorities as a relevant party) in a panel's consultation under FTCA process. Our advice incorrectly named Ngaa Puna o Wairere as the Ngaati Wairere representative. This needs to be corrected in the two notices of decision sent for the respective projects.

- 11. Specifically, we would not have recommended you specify the applicant provide visual representations of the turbines as this should be provided as part of a landscape and visual assessment which is covered by clause 9-11 of Schedule 6 of the FTCA.
