Project name	Rangitane Reclamation and Boat Ramp Maritime Development
General comment – potential benefits	Benefit to the growing Kerikeri boating community by providing improved boat launching and retrieval facilities with capacity for trailer and vehicle parking. Improved access to the coastal marine area (CMA) to the general public as well. Such facilities experience high demand year round. There are limited public facilities available within the Bay of Islands generally.
General comment – significant issues	Proposal involves reclamation of common marine and coastal area – Policy 10 of New Zealand Coastal Policy Statement and policy D.5.20 of the Proposed Regional Plan for Northland have strong avoidance policies in respect of reclamation, unless all elements of the of the policies can be satisfied.
Is Fast-track appropriate?	No comment on appropriateness.
Environmental compliance history	Both Far North Holdings Limited and Far North District Council have multiple consents for coastal structures and activities in the CMA. There is long compliance history for both applicants regarding coastal consents which has been generally good.
Reports and assessments normally required	Application contains overview statements on ecology, coastal processes, landscape and natural character, noise and traffic management. Comprehensive reports would normally be required by council for a project of this scale and nature. A comprehensive planning assessment report would also normally be required, and as the proposal involves reclamation the planning assessments would normally contain supporting documentation demonstrating regional significance of the proposal and the necessity for the reclamation. Assessments of proposal against relevant statutory documents in respect of climate change and sea-level rise would also normally be required - usually within the comprehensive planning assessment).
lwi and iwi authorities	Te Runanga O Ngati Rehia, Ngāti Torehina Te Runanga A Iwi O Ngapuhi.
Relationship agreements under the RMA	Transfer of functions and powers between the Northland Regional Council and Far North District Council. Northland Regional Council process land-use consents for portions of jetties and boat ramps landward of the mean high water springs mark.
	The Northland Regional Council has a Mana Whakahono a Rohe agreement with Ngati Rehia.

Insert responses to other specific requests in the Minister's letter (if applicable)	The Regional Harbourmaster for Northland does not have any navigational safety concerns with this application. He has indicated that the proposal is in a suitable area with good access to open water, and that the far north is also in need of launching facilities	
Other considerations	The council is aware of some opposition to the proposal from within the local community who have concerns about increased traffic, and noise arising from potential for increased boat launching activities in early morning and at night. Concerns expressed about use of nearby public open space for additional (overflow) vehicle and boat trailer parking.
