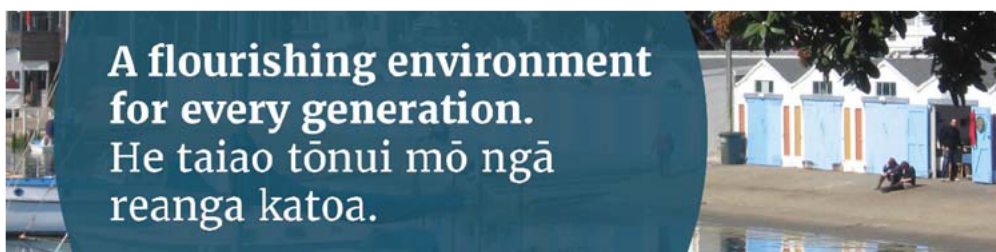

Hi Rebecca and Zen,

The other thing we had to confirm was the status of MPI aquaculture decision. s 9(2)(a) check in with MPI again and they confirmed that the existing 'Undue adverse effects test' (UAE) would continue stand after the Wakatu resource consent has expired, i.e. Plant and Food does not need to make its own UAE application. Apparently once space has been assessed it will never need to be assessed again – along as you stay within the original footprint.
