This is fine to progress with Fast Tracking In doing so that we consider the following factors which make the fast tracking process:

1. Acanthus will need to seek updated CVA's for the final resource consent designs (and consent conditions) prior to submitting the resource consent application;

- 2. Acanthus would be supportive of the Minister listing the iwi authorities who have provided a CVAs as persons/parties that the expert consenting panel must seek feedback from pursuant to section 24(2)(e) of the COVID-19 Recovery (Fast-track Consenting) Act 2020 ("FTCA");
- 3. Section 6 of the FTCA is a stronger obligation than is found in the Resource Management Act 1991 as all persons exercising functions (including both the Minister and the Expert Consenting Panel) must act in a manner that is consistent with the principles of the Treaty of Waitangi and treaty settlements. Therefore, it seems that iwi authorities are in a stronger position under the FTCA than they are under the RMA;
- 4. The Minister's fast-tracking does not guarantee that consent will be granted.
