## COVID-19 Recovery (Fast-Track Consenting) Act 2020 - Notice of Decision (Section 25) - Selfs Road Project

Thank you for Acanthus Limited's application under section 20 of the COVID-19 Recovery (Fast-track Consenting) Act 2020 (FTCA) seeking referral of the Selfs Road Project (project) to an expert consenting panel (panel) for consideration under the FTCA.

The project is to subdivide a 3.64-hectare site and construct approximately 115 single-level residential units, private accessways for vehicles, infrastructure for three-waters services, and a public pedestrian ridgeline walkway at 1 Selfs Road, Papatoetoe, Auckland.

The purpose of the FTCA is to promote employment to support New Zealand's recovery from the economic and social impacts of COVID-19 and to support the certainty of ongoing investment across New Zealand, while continuing to promote the sustainable management of natural and physical resources.

I can only refer a project to a panel for consideration under the FTCA if it meets the referral criteria in section 18 of the FTCA. I can also decline to refer a project for any reason, under section 23(2) of the FTCA. This is not a criticism or endorsement of a project.

I have decided to decline your application for referral under section 23(2) of the FTCA as I consider it is more appropriate for the project to go through standard processes under the Resource Management Act 1991.

- 2. My decision, the reasons for my decision and the Section 17 Report will be published on the Ministry for the Environment's website in accordance with section 25(3) of the FTCA.
