#### Kia ora Rebecca

- 1. Many thanks for your assistance in relation to the Mansion Rear Limited ("MRL") referral application to date. You indicated on 3 March that an MfE analyst would be in touch in due course regarding this referral application. We have not heard from an analyst yet but we are very keen to make contact and discuss any further material that might be required.
- 2. The purpose of this note is to:
  - (a) Update MfE on the status of our consultation efforts with relevant iwi authorities; and
  - (b) Seek some guidance as to what further action is considered necessary.
- 3. On Thursday 16 February 2023 and Friday 17 February 2023, we sent an email and memorandum to the twelve relevant iwi authorities (attached) informing them of the proposal and seeking a response as to whether they have a cultural interest in the proposal. These iwi authorities contacted had been

identified by Auckland Council as mana whenua for the area surrounding the Site.  $^{[1]}$  The iwi authorities which were informed comprised:

- (a) Ngāi Tai ki Tāmaki Tribal Trust;
- (b) Ngati Manuhiri Settlement Trust;
- (c) Ngāti Maru Rūnanga Trust;
- (d) Ngāti Paoa Iwi Trust;
- (e) Ngāti Pāoa Trust Board;
- (f) Te Ara Rangatu o Te Iwi o Ngāti Te Ata Waiohua;
- (g) Ngāti Whanaunga Incorporated;
- (h) Ngā Maunga Whakahii o Kaipara Development Trust;
- (i) Ngāti Whātua Ōrākei Trust;
- (j) Te Ākitai Waiohua Iwi Authority;
- (k) Te Kawerau Iwi Settlement Trust; and
- (I) Te Rūnanga o Ngāti Whātua.
- 4. Paragraph 4.1 of the letter stated:

"We understand that the location of the Site may be outside your identified area of interest. As such, we would appreciate it if you could please advise us of your cultural interest in the proposal within 15 working days, **by COB Thursday 15th March 2023**, indicating whether you would wish to engage in the fast-track process should the application of the Site's development for referral to the EPA be successful."

- 5. On 20 February 2023, we received a response from Courtney Shaw on behalf of Manuhiri Kaitiaki Charitable Trust advising that they would like to express an interest in providing a cultural response. However,
- 6. No other iwi authorities who were contacted have provided a response.
- 7. We would be grateful for MfE's guidance as to the extent we should seek to follow up iwi authorities from which we have had response. Perhaps you could get our analyst to follow this up with us.
- 8. Happy to discuss.

- 1. Another busy week for 2023.
- 2. We have received your Fast-track referral application for Mansion Rear. The analyst will be in contact in due course.
- 3. The substantive resource consent/NOR application to the EPA can be lodged after 8 July 2023. The last day to lodge a complete application with the EPA is 11 January 2024. The savings provisions apply until 8 January 2024, 6 months from the date of repeal on 8 July 2023, extended to 11 Jan 2024 (as the next working day). We recommend early engagment with the EPA to ensure adequate timing for the EPA's completeness check of any application prior to the last day.

## Ata marie Rebecca,

- 1. I hope you have had a nice (and not too hectic!) week.
- 2. You might recall that we spoke on 7 February 2023 about the times frames for lodging FT referral applications, etc. Since then we have lodged (on 23 February 2023) an FT referral application for Mansion Rear Limited for a mixed use development at 8 Stevensons Cres., Albany.
- 3. I have another question for you concerning the correct interpretation of Clause 1(2) of Schedule 1 of the Covid-19 Recovery (Fast-track Consenting) Act 2020, which states:

"This Act, and any Order in Council made under this Act that is in force on the day before the Act is repealed, remains in force for the purpose of completing any matter commenced under the Act before its repeal or under the order before its revocation.

- (3) The matters referred to in subclause (2) include, without limitation,—
- (a) a panel's decision on a consent application or notice of requirement that is lodged with a panel, in accordance with clause 2 of Schedule 6, before the date that is 6 months after the repeal of this Act."
- 4. Our understanding is that as long as the relevant project has been referred to the fast track via the necessary Order in Council, the substantive resource consent application to the EPA can be lodged after 8 July 2023, being the date of repeal. (It has been suggested that the substantive application should also be lodged by the date of repeal but that does not make sense to me.)
- 5. I would be most grateful if you could confirm that our interpretation is correct as it affects our planning of timing for inputs into the AEE, etc.
- 6. Many thanks in advance for your assistance. Happy to discuss.


