COVID-19 Recovery (Fast-Track Consenting) Act 2020 – comments sought on referral applications – Te Rere Hau Wind Farm: Aokautere Extension Project Out of Scope

The Minister for the Environment (the Minister) received applications to refer the following two projects to an expert consenting panel (a panel) for consideration under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (FTCA):

1. Te Rere Hau Wind Farm: Aokautere Extension Project – from NZ Windfarms Limited
Out of Scope

The purpose of the FTCA is to promote employment to support New Zealand's recovery from the economic and social impacts of COVID-19 and to support certainty of investment while continuing to promote the sustainable management of natural and physical resources.

The projects are described in Appendix A and the application documents are in Attachments 1 and 2.

Transpower may have an interest in the projects because they may require your approval to connect to the national grid. Under delegated authority from the Minister and pursuant to section 21(3) of the FTCA, I invite your written comments on the referral applications. A template is provided for this purpose in Attachment 2.


The above information is provided to you in confidence and as part of the statutory process set out in the FTCA. Please do not forward the applications or request for comments to anyone outside your organisation.

If the Minister accepts the applications and the projects are referred to a panels, the applicants will be able to lodge applications with the Environmental Protection Authority for the approvals needed under the Resource Management Act 1991. The applicants must provide a detailed assessment of environmental effects and cultural impact assessment(s) as part of this process.

Please provide comments via return email within 10 working days to ensure that the Minister takes them into consideration when deciding whether or not to accept the referral applications. Note that the Minister is not required to consider any comments provided after this time.
