COVID-19 RECOVERY (FAST-TRACK CONSENTING) ACT 2020 – REQUEST FOR FURTHER INFORMATION – WHENUAPAI DEVELOPMENT PROJECT

You have asked Cabra Developments Limited to provide further information in respect of the Whenuapai Development project pursuant to section 22 of the FTCA. We provide the following response accordingly.

1. In the event approval from Auckland Transport is not obtained for the proposed Sinton Road extension, provide an alternative design for Site C, including any change to the number of lots/residential units.

The project team has thoroughly considered the potential implications on the layout of Site C in the event approval from Auckland Transport is not obtained to extend Sinton Road to the south east.

The **attached** site layout provides one such example whereby the new vested road is located in the position of the existing vehicle crossing. In this alternative scenario, the proposed vested road would have complete frontage to the existing formed Sinton Road, and no further extension would be required to provide access to Site C.

The alternative scenario provides a total of <u>80 residential dwellings</u> within Site C, whereas the preferred layout (as lodged) provides a total of 81 residential dwellings.

While there is little difference in yield, the preferred layout (as lodged) offers a centralised intersection facilitating a more efficient layout with dwellings located on both sides of the vested road, as opposed to a single-loaded vested road. The preferred layout therefore facilitates a typical streetscape in respect of design, character and appearance. It also reduces the length of the jointly owned access lots internally within the site, which is beneficial from an urban design and CPTED perspective. Ultimately however, these matters do not present 'fatal flaws' should approval from Auckland Transport not be obtained to extend Sinton Road.


2. The number of potential ongoing full time equivalent jobs in the industrial sites.

Formative Economics has advised that the potential ongoing full time equivalent jobs at Site D, the industrial site, is estimated to be in the order of 126 FTEs (refer **attached**).
